5) Treasurer's Report

I have reviewed all transactions since the last meeting. No entries of concern were noted. I made only minor changes in account assignments to align expenses with budgeted accounts. The attached reports are after any changes and reflect entries made in QuickBooks through 10/16/2024.

Total Bank Balances: \$547,946.26

This is after paying for:

The new Dodge RAM 2500 truck for the EMTS grant. Chief has a cashier check in hand for \$46,360.43 to pick up the truck this week. We will have additional expenses to upfit the truck with lights, sirens, radios, topper, slide-out, off-road tires and a snowplow. Remember we will be reimbursed through the grant for approximately ½ the total cost. Total projected cost (including radio) in the grant is \$75,950.81 with a reimbursement of \$34,469.15 once the truck is fully outfitted. The IRS penalties and interest for tax years 2018-2022 are all full paid. We had 14 quarters during that time period with outstanding penalties and interest. We received a letter from IRS this week acknowledging receipt of our request to abate the penalties (sent 5/23/2024) – they said they need an additional 90 days to consider that request.

The LUCAS is full paid (\$19,980) and in service on R52. A \$5,000 deposit for the office buildout has been paid.

We are in good shape on our Budget vs Actual.

Our total revenue is at 113.28% of the annual budget.

Our total expenditures are 66.35% of the annual budget. We are approximately 75% through the year and almost all major budgeted expenses have been paid. The rest of the year should be mostly normal operating expenses plus the outfitting of the new EMTS truck.

I will be proposing that we cash in a money market CD held at Community Banks. That \$5,544 CD automatically renewed on 3/13/2023 for 5 years (maturity 3/13/2028) at 1.95% (roughly \$108/yr). The penalty for early withdrawal is 730 days (2 yrs) of interest (roughly \$217). Our Colotrust account is currently paying 5.1% (roughly \$283/yr). If we take the money out of Community Banks and put it in Colotrust, we will recover the amount of the early withdrawal penalty in less than one year.
